## 1. INTRODUCTION

- 1.1 This statement details the charges to persons (Users) using the Electricity Network Company Limited's (ENC) and Independent Power Networks Limited's (IPNL) Electricity Distribution System for the provision of metering point administration and data services.
- 1.2 Any reference to 'Our' or 'We' relates to both The Electricity Network Company and Independent Power Networks
- 1.3 The statement has been prepared in accordance with the requirements of licence condition 14A of the Electricity Distribution Licence granted in accordance with the provisions of the Electricity Act 1989 (as amended from time to time).
- 1.4 The charges are provided pursuant to Schedule 8 of The Master Registration Agreement. Additional services will be quoted separately and billed in accordance with the Distribution and Connection Use of System Agreement (DCUSA).
- 1.5 The Licence requires that the terms and charges contained in this statement may be reviewed at least once each year. The charges and costs shown will apply from the 1<sup>st</sup> April 2016 and are exclusive of VAT. They will not be changed except as provided for in the relevant DCUSA schedule and subject to the requirements of Standard Condition 36 of the Licence.
- 1.6 This statement has been prepared in a form approved by the Gas and Electricity Markets Authority (the 'Authority').
- 1.7 ENC's and IPNL's charging statements on the:
  - Use of System (UoS) Charging Methodology (SLC13);
  - Use of System (UoS) Charges (SLC14); and
  - Connections Charging Methodology and Statement.

are published separately and available via the relevant website.

- 2.1 The applicant will be required to be a signatory to the Master Registration Agreement (MRA) for the provision of registration services.
- 2.2 In accordance with Licence Condition 23, Metering Point Administration System (MPAS) are provided under the MRA. Users should contact Master Registration Agreement Service Company (MRASCo) if they wish to become a party to this agreement.

Such charges and any variations are and will be calculated in accordance with the provisions of the Relevant Charging Statement.
